Schedule A - Single-Dwelling Unit Residential Customers

The number of hundred cubic feet (HCF) of water (one HCF equals 748 gallons) available to Schedule A customers at the Tier 1 rate is based on five lot size categories, three temperature zones, and household size. Customers with a household size of more than six (6) persons may apply to have their first tier allowances increased by calling 1-800-DIAL-DWP (1-800-342-5397). The basic first tier allowances provide for up to six persons in a household.

Beginning June 1, 2009, shortage year rates became effective and will be applied to all LADWP customers. Under Shortage Year Water Rates, Tier 1 allotments are reduced by 15%. Customers can find out their Tier 1 water allotment by viewing ▶ Charts A & B, logging in to their account →, or calling 1-800-DIAL-DWP (1-800-342-5397). Chart B shows the first tier usage block adjustments for household sizes larger than six (6) persons.

Water Lifeline Rate Customers

Water Lifeline customers receive a subsidy of up to \$20 every two months on their water bill. However, the subsidy should not exceed the customer's water bill. To qualify, customers must be eligible for exemption from the City Electricity Users Tax under provisions of the Los Angeles Municipal Code by reason of senior citizen or disability status and household income. For qualification requirements and to fill out an application, please call the Customer Contact Center at 1-800-DIAL-DWP (1-800-342-5397) or go to Discount Rates →.

Water Low Income Discount Program Customers

Water Low Income customers receive a subsidy of up to \$10 every two months plus \$2 per person for households over three (3) persons, up to a maximum total subsidy of \$20 per bill. The subsidy should not exceed the customer's water bill. Any customer whose total household income does not exceed the limits established by the Board of Water and Power Commissioners is eligible. For qualification requirements and an application, go to Discount Rates \rightarrow or call the Customer Contact Center at 1-800-DIAL-DWP (1-800-342-5397).

Electric Low Income Discount Program and Lifeline Rate Customers

Electric Low Income and Lifeline customers who are not billed for water service will automatically receive the Water Low Income subsidy on their electric bills in addition to their electric subsidies. The subsidy however, should not exceed the customer's electric bill.

First Tier Usage Block

During the High Season months, the Tier 1 usage during normal years for each meter is 125% of the average consumption for the preceding December through March, or 28 HCF each month, whichever is greater. New customers that have not established a first tier usage block are billed at the Tier 1 rate until a first tier usage block is established for the next High Season period.

Beginning June 1, 2009, shortage year rates became effective and will be applied to all LADWP customers. Under Shortage Year Water Rates, Tier 1 allotments are reduced by 15% and Tier 2 rates are applied year-round. For specific tier water allotments, customers can log in to their account → or call 1-800-DIAL-DWP (1-800-342-5397).

General Provision N - High Seasonal Variation in Usage

During the High Season months, Schedule B customers may be eligible for reduced bills under General Provision N of Rate Ordinance number 170435 if their consumption for each of two consecutive High Season monthly billing periods is more than 200% of their winter average consumption (December through March) and is also at least 26 HCF above their first tier usage block. Customers that qualify are allowed 95% of their usage at the Tier 1 rate. The Provision N application includes a self-certified water conservation audit. For further information or to apply, please call (213) 367-0944.

General Provision M - Large Irrigated Turf

Schedule C customers with 3 acres or more of turf providing water for landscape only may be eligible for increased first tier allotments under General Provision M of Rate Ordinance number 170435. Customers that qualify are allowed 95% of their usage at the first tier rate. Customers must have first completed an audit of their water use in their premises in accordance with an LADWP approved manual on large turf water audits and have implemented the "Best Management Practices for Turf Irrigation" as approved by the Board of Water and Power Commissioners to the satisfaction of the LADWP. Two Inch and Larger Meters

During the Low Season months, bills for Schedule C customers that have two inch or larger meters are computed based on a discounted commodity charge (rate without surcharge adjustments) that is reduced by the following percentage amounts:

Effective Nov. 27, 2006: 22% Effective Nov. 1, 2007: 13% Effective Nov. 1, 2008: 7% Effective Nov. 1, 2009: 0%

General Provision N - High Seasonal Variation in Usage
