## **JOB SUMMARY**

Supervise the operations activities of one or more water filtration plants, associated distribution systems, and/or power generation plants to meet Metropolitan water quality and supply standards in an environmentally and economically responsible and safe manner. Coordinate all maintenance activities relating to area of responsibility.

**ESSENTIAL FUNCTIONS** – Essential and other important responsibilities and duties may include, but are not limited to, the following:

- 1. Supervise treatment plant and distribution operational activities directly related to the water treatment and distribution process to ensure that the plant operates in accordance with state and federal health rules and regulations for a public water system. Review operational methods within current procedures and guidelines and implement modifications as required.
- 2. Coordinate plant maintenance activities with other supervisors to avoid unplanned outages and maintain employee safety. Ensure that proper outage requests and switching and valving instructions are completed and communicated to other areas.
- 3. Meet with Metropolitan engineering staff to provide input from an operational perspective on expansions, modifications, enhancements, and/or problems related to operational equipment.
- 4. Requisition materials, chemicals, equipment, and supplies necessary to treat and meet water quality standards. Supervise changes of chemical feeds, operational equipment, and the implementation of new treatment techniques to ensure compliance with all regulations involving water quality parameters.

- 5. Supervise the operation of wastewater and sludge handling systems to ensure proper treatment and disposal in a cost-effective manner.
- 6. Assist in the supervision of staff including selecting employees, assigning work, providing training and development evaluating performance, and building a motivated, effective team to ensure that organizational, goals for diversity, career development, productivity, performance management, and employee involvement are met.
- 7. Perform administrative activities including completing timesheets; preparing reports on monthly activities and statistics, chemicals received and used, preliminary cost estimates, and daily and monthly plant and distribution flows; and conducting periodic reviews and revisions of operations manuals.
- 8. Implement and monitor safety training and monitoring programs and safety procedures to ensure compliance with state and Metropolitan requirements for water treatment operators. Review and revise policies and procedures, as required, to maintain workforce health and safety and compliance with Environmental Compliance Division guidelines.
- 9. Serve as an Incident Commander in the Metropolitan Emergency Response Program to ensure that chemical and hazardous material spills are handled in accordance with state and federal regulations. Serve on 24-hour call and respond to treatment plant and distribution emergencies to resolve the emergency efficiently and safely and to ensure proper notification and documentation.
- 10. Perform other related duties as required.
- 11. Coordinate and assist in tours with representatives of member agencies, governmental agencies, and the public in order to enhance mutually positive working relationships with external entities.

### **MINIMUM QUALIFICATIONS**

#### **Education and Experience:**

• A combination of education and experience in water treatment or distribution systems operations totaling 6 years, 1 year of which must have been at the supervisory or lead level.
